PAF's mission is to advance sustainable mobility solutions improving Malta's traffic situation, thereby enhancing quality of life and environmental conditions for the Maltese population






#### PAF - Strategic objective

## Why is mobility important for sustainability?

There have been important developments with impact on urban mobility, such as the growing importance of cities, disruptive changes in transport and mobility of both technological and societal nature, as well as rising mobility (congestion), health (air pollution) and climate (emissions) challenges.







## PAF - Sustainable Mobility Systems

A sustainable mobility system is one that:

- Allows the basic access needs of individuals and societies to be met safely and in a manner consistent with human and ecosystem health, and with equity within and between generations.
- Is affordable, operates efficiently, offers choice of transport mode, and supports a vibrant economy.
- Limits emissions and waste within the planet's ability to absorb them.




#### **Target 11. 2**


